- Chat and Communications: Messages sent within our ROBLOX experiences (subject to ROBLOX's moderation)

Note: We do not have direct access to your ROBLOX account information. All interactions are governed by ROBLOX's Terms of Service and Privacy Policy.

How We Use Your Information

We use collected information for the following purposes:

Service Provision

- Operating and maintaining our website and ROBLOX experiences
- Providing customer support through Channel Talk
- Responding to your inquiries and communications
- Processing newsletter subscriptions

Analytics and Improvement

- Understanding how users interact with our website and experiences
- Analyzing website performance and user behavior through Google Analytics
- Improving our services, website functionality, and user experience
- Conducting research and development for new features

Marketing and Communication

- Sending newsletters and updates (with your consent)
- Collecting feedback through surveys and forms
- Promoting our ROBLOX experiences and services

Storage Locations

- Primary Data: Stored on servers located in Poland
- **CDN Content**: Distributed globally through Cloudflare's network for improved performance
- Third-Party Services: Stored according to each service provider's data location policies

Security Measures

We implement appropriate technical and organizational measures to protect your personal information, including:

- Encryption of data in transit and at rest

Data Retention
